December 14th to Guarantee Delivery of Gifts Before the Christmas Break

(Bulk delivery customers must select an end date no later than December 7. Delivery will occur by Dec 14 to allow schools time to distribute.)

REMEMBER – Once you have started marketing your shop and sharing your Virtual Shopping Website there is no need for Volunteers until after your sale is completed. Fun Services will either deliver the gifts to your school, or directly to the homes of your students.

You can earn a higher percentage if you take on the task of distributing the gifts to the students. We know some new rules may not allow for this so now there is also the option for us to ship/deliver directly to homes.
